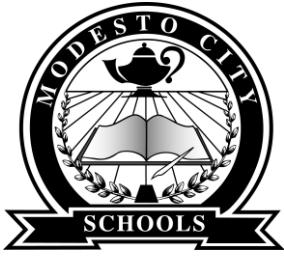
The position is open to current sophomores and juniors in Modesto City Schools. To apply for the position, you must submit the attached application by 5 p.m. on Monday, April 18, to the Public Information Office, 426 Locust Street, Modesto, CA 95351.

The application is a PDF form. Complete the application online, then print the document to obtain the appropriate signatures. **Late, handwritten or incomplete applications will not be accepted.** Applicants will be notified via email on Monday, April 25 whether or not they will be awarded an interview.

Up to eight candidates will be interviewed by a panel consisting of one Inter-High Council representative or leadership student from each high school, the current Student Representative to the Board of Education, one Board of Education member and the Public Information Officer. The interviews are scheduled to take place Thursday, May 5, from 2:30-4:30 p.m.

BB 9111

### BOARD OF EDUCATION

#### Student Member

In recognition of the need to maintain good communication with students and to obtain their reactions and feelings regarding District programs and policies, a non-voting student seat on the Board of Education is established.

1. The student appointed to serve shall be enrolled in the Modesto High School District during the period of service.
2. The student member shall be entitled, and is expected, to attend each and all Governing Board meetings except Closed Session.
3. The student member may receive a mileage reimbursement if requested to travel outside the area on District business.
4. The term of the student member is for one year commencing July 1.
5. The student member shall be recommended by the Modesto City Schools Inter-High Council to the Board of Education for approval.
6. By approval of Resolution No. 96/97-22, the Board of Education authorized preferential voting by the Student Representative to the Board, except on matters dealing with employer-employee relations pursuant to Chapter 10.7 (commencing with Section 3540) of Division 4 of Title 1 of the Government Code.
7. Preferential voting means a formal expression of opinion that is recorded in the minutes and cast prior to the official vote of the Governing Board. A preferential vote will not serve in determining the final numerical outcome of a vote. No preferential vote can be solicited on matters subject to closed session discussion. The preferential voting student shall not be liable for any acts of the Governing Board.

8. By approval of Resolution No. 97/98-14, the Board of Education authorized the Student Representative to the Board to make motions that may be acted upon by the Board of Education, except on matters dealing with employer-employee relations pursuant to Government Code 3540-3549.3.

### STUDENT MEMBER SELECTION

1. Applications for the position of Student Representative to the Board of Education will be made available to all interested high school sophomores and juniors during the first week of April of each year. They will be available for a two-week school period.
2. Students will be notified of the vacancy through school bulletins and meetings, posters and media announcements.
3. The interview and selection panel will be made up of one Inter-High Council representative from each participating high school, the current Inter-High Council president, the current Student Representative to the Board of Education, a Board of Education member and the Superintendent's designee.
4. The interview and selection panel will schedule interviews approximately one week after all applications have been received by the Public Information Officer.
5. All applicants will be invited to appear before the panel for a 10 to 15 minute interview. Students should be prepared to discuss why they want to be the Student Representative to the Board of Education. Prior to beginning the interviews, each panel member will be given copies of the applications of the students scheduled to be interviewed. Panel members will ask the same series of questions to each applicant.
6. If a student is unable to meet with the panel on the appointed day, the panel will render a decision based upon the circumstances.
7. At the end of the interview sessions, the panel will decide on their choice for the new Student Representative to the Board of Education. If a tie exists, the panel may interview the top candidates again.
8. The new Student Representative to the Board of Education will be introduced to the Board of Education, and to the Inter-High Council during the last meeting in May by the outgoing Student Representative to the Board of Education.
