School Description and Mission Statement (School Year 2017-18)

Our Vision Statement: PAWS: Positive learning environment; Accelerated academic growth; Warm hearted atmosphere; Scholars of the 21st century. El Vista was built in 1953. We are located in the southeast section of Modesto, California. Our student body consists of 61% Hispanic or Latino, 21% White, 4% African American, and 11% Other. Additionally, 91% of our students are Socioeconomically Disadvantaged and 30% are English Learners. Our Child Development Programs house two State Preschool classrooms and two Head Start classrooms with approximately 100 students enrolled. We also house four Special Education Severely Handicapped classrooms and sixteen Kindergarten through Sixth Grade classrooms with approximately 410 students enrolled. We also house the ASES (After School Education and Safety) program on our campus. During the years there have been many additions to the facility. In the summer of 2016 our campus underwent a major process of resurfacing the playgrounds, enhanced lighting, enlarging the parking area, and other repairs.

In addition to the K-6 classrooms and staff, El Vista has one computer literacy teacher, one library media assistant, one Speech and Language Therapist, one part-time School Psychologist, one Student Assistant Specialist, one After School Program Director, one resource aid, 12 para-professionals, one Administrative Assistant, one Attendance Clerk, one part-time bilingual TCII, three Custodians, three Food Service Employees, one Campus Assistant, and five Yard Duties. We also have a school nurse regularly on our campus.

During the 2016-17 school year El Vista students completed the Smarter Balanced Assessment Consortium (SBAC) for the third time. The results have been reported and we now have a baseline for future growth. Our 5th graders continue to take the CST Science Test and the Physical Fitness Test mandated by the State of California. School-wide reading intervention/enrichment was implemented during the 2014-15 year, and continues to be done. The intervention uses Phonics for Reading and Rewards to teach students.

Modesto City Schools provided 15 early release days during the 2016-17 school year that allowed the teachers collaboration time. Teachers will be provided 14 more days during the 2017-18 school year. During collaboration, teachers meet in grade level teams to discuss student data, compose SMART Goals and common assessments to monitor student progress. During the 2015, 2016, and 2017 summers, El Vista's teachers and leadership team went to a conference on Professional Learning Communities (PLCs). In 2018, more teachers and leadership members will attend the conference as well. The information from this conference helped to reshape the purpose and duties of our PLC's.

El Vista is committed to building the character of every student through promotion of the Modesto City Schools Character Education Program. We routinely start our weeks off with Monday Matters, a brief, lifting and informative assembly to start the week right. During the 2016-17 school year our counselors presented Peace Builder lessons to El Vista classrooms and El Vista continues to implement the Positive Behavior Interventions and Support (PBIS) strategies throughout the campus. We have also implemented the Restorative Justice model of reconciling differences and issues between students. We have motivational and positive behavior signs and reminders throughout the campus. We use Bull Dog Bucks to reinforce positive behavior and the Bull Dog store where the students can spend their "bucks". We also have lunch with the principal and school dances to reward students for their behavior. Decreasing suspension rates continues to be important at El Vista because of these positive interventions. Additionally, attendance at El Vista continues to increase, noting the highest percent increase in the district for the 2016-17 school year.

Parents are encouraged to participate in activities at El Vista. During the 2017-18 school year they will be invited to participate in Back to School Night, Second Cup of Coffee, Coffee with the Counselor, Student of the Month Assemblies, End of Trimester Awards, ELA Night, Math Night, Muffins and Math, The English Learner Parent Partnership, School Site Council, and the Parent Involvement and Engagement Committee. We have Spanish translation for most of our events regularly. We also hosted the Developmental Assets Parent Meeting facilitated through the district. The Student Council has become very active on the campus with fundraising and engagement activities, including scheduled Family Movie Night Under the Stars.

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the State of California Office of Public School Construction. In an effort to keep students safe on school grounds before, during and after the school day we have these plans in place: 1) Students are allowed on school grounds during the time of contracted supervision beginning at 8:00 a.m. Two yard duty employees and three Special Ed Paras monitor the playground/bus arrivals until classes begin at 8:40 a.m. After school crowd control/bus departures are monitored for 30 minutes after dismissal; 2) Monthly character education focus; 3) Peace Builders and Restorative Justice programs; 4) The district Student Conduct Code is enforced to maintain high standards of behavior.

School Facility Conditions -- General Information

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are included within this report. The results of this survey are available at the district office and on the internet at mcs4kids.com.

Age of School/Buildings:

This school has 27 classrooms, a cafeteria, a library, a head-start and an administration office. The main campus was built in 1953. Additions were constructed in 1955 and in 1959. Eight portable classrooms were constructed over the periods of 1989, 1990, 1997, and 2001. The parking lot was expanded in 2016. The school opened in 1953.

Maintenance and Repair:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service. Emergency repairs are given the highest priority. The school facility is in overall good repair.

Cleaning Process and Schedule:

The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards are available at the school office, or at the district office. The Principal works continually with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget:

The District participated in the State School Deferred Maintenance Program, which provided flexible state matching funds to assist school districts with expenditures for major repair or replacement of existing school facilities components. State contributions to this Program ended in the 2012-13 school year. Deferred Maintenance typically includes paving, roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting and floor systems. For the 2016-17 school year, the district budgeted \$0.69 million out of the District General Fund carry-over funds for deferred maintenance projects throughout the District. The District also has 1.28 million of carry-over funds in Fund 14 Deferred Maintenance Fund available for deferred maintenance projects throughout the District. Identified needed repairs are weighed against all other District site repairs and the most urgent repairs are addressed first.
